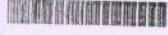
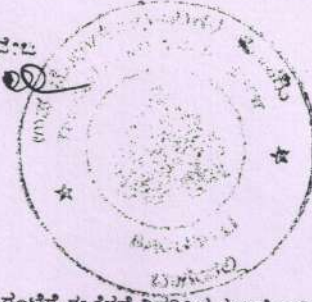

b. the benefit of the Trust and its objectives shall avail to all persons irrespective of caste , creed, colour, sex or religion.

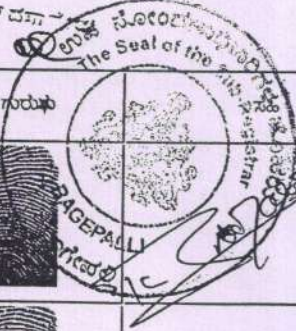

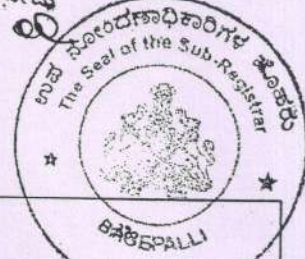

- 25.To borrow money, raise loans, advances, by applying to Banks, Nationalized or otherwise, including , Co-operative Banks, financial institutions, land banks by calling for deposits , loans by executing negotiable instruments or guarantee bonds or surety bonds or in any other manner within the provisions of law and for that purpose to create a mortgage charge, lien or any or all of the immovable or movable properties belonging to the trust, to secure such loans, advances, advances and deposits.
- 26.To apply for grants, benefits, donations, contributions – Governmental or quasi- governmental grants, sanctions, loans, for the attainment of object of the Trusts, and to execute such documents, deeds, undertakings, bonds, declarations as may be required in respect thereof.
- 27.To publish and disseminate literature of such nature as to further the objects of the Trust.
- 28.The Trustees shall meet at least once a month at such place or places as maybe decide from time to time. The meeting of the Trustees shall be presided by the Chairman of the Trust. The quorum for any meeting shall be any two trustees.
- 29.The Trustees shall maintain or cause to be maintained, regular and proper records of the meetings and decisions in the form of minutes or Notes or any manner appropriate. All Trustees present in such meeting shall sign such minutes or notes and they shall become final and its correctness shall not be called to questioned subsequently. The Trust shall also maintain or cause to be maintained proper, correct and regular books of accounts shall be audited and certified by a qualified Chartered Accountant each year. The Trustees shall ensure that returns of income tax and other statutory

elected shall hold the said office for a term of three years, with such process continuing in rotation till perpetuity.

2. Notwithstanding anything hereinbefore or after contained, the trustees shall be entitled to co-opt a maximum of two persons to act as trustees for a period not exceeding 2 years. Such person so co-opted shall not have the power to vote. On the expiry of two years, the co-opted Trustees shall automatically cease to be trustees.
3. Without prejudice and in addition to the generality of power required by and arising out of the objects of the trust, and without restricting any power required for administration of the trust, the trust shall for the purposes of more fully and effectively achieving the objects of the trust and to have the following specific powers:-
 - a. To appoint, retain, utilize, terminate the services of any legal practitioner, firm of advocates, Solicitors, Chartered Accountant, Accountants, Tax Consultants, Management Consultants, Architects, Engineers, Contractors or any other professional or person whose services or assistant is required for the administration and welfare of the trust or for carrying out any of the objects/ activities of the trust on such terms and conditions as may be decided upon by the Trustees from time to time.
 - b. To frame schemes for implementation of any of the objectives hereinbefore specified supra to prescribe and determine, among other things, the qualifications, conditions, terms, tenure, amounts, administrative details, selection procedures, sub committees, groups or terms to discharge any function that maybe allotted by the Trustees.

- c. To lay down, determine, postulate, procedures, issues directions, orders managing the day- to -day affairs and business of the trust and adopt measures for the implementation of the same.
- d. To incur or authorize the incurrence of all legitimate expenditure in the furtherance of the objects of the trust including expenses relating to advertisements, publicity, rentals, salaries, wages, provident fund, gratuity, telephones, office and travel expenses connected with the administration of the Trust or its objects.
- e. To enter into contracts, hire- purchase agreements, reciprocals, promises, obligations, commitments, for the more effective administration and fuller achievements of the objects of the Trust.
- f. To sue, commence, continue, defend, prosecute, initiate any legal proceedings including criminal actions, complaints, prosecution or to recover debts, monies, or to enforce obligations, contractual or otherwise or to recover compensation, damages for breach of contracts either jointly or by authorizing anyone or more Trustees in that behalf and to compound, comprise, relinquish any right, dispute, suit, proceedings, debt, money, obligations in the interest of the trust.
- g. The trust shall invest surplus funds remaining after expending its funds on any or all the objects of the Trust, in the manner prescribed under the Indian Income Tax Act, particularly Sec. 13 (1) (d) and 11 (5) thereof. In the event of it becoming necessary to accumulate funds of the Trust for the purposes of expending the same at a time in future, such

accumulation shall be strictly in accordance with provisions relating thereto in the Indian Income Tax Act as amended or in force from time to time.

NOTWITHSTANDING anything hereinbefore contained, any two Trustees (excluding the co-opted Trustees) shall be entitled to call for a special meeting of the Trustees provided that a written request addressed to the registered office of the Trust is made in that behalf stating the reasons and Agenda for such meeting. The remaining Trustees shall within 30 days thereafter convene a meeting of the Trustees, for the specific purpose of a decision, consideration of the Agenda so proposed.

4. The Trustees shall not be entitled to receive any fees, honorarium or payment for the discharge of their duties and obligations as Trustees, Provided however that the trustees shall be entitled to be reimbursed any legitimate expenses incurred in the discharge of their duties as Trustees, including Travel Expenses, provided such expenses were incurred directly and solely for the benefit and welfare of the Trust and in furtherance of the objects of the Trust and PROVIDED further that a Trustee who devotes his own time and attention to the administration, affairs, and activities of the Trust and / or renders professional services or specialized inputs in addition to discharging duties as Trustee shall be entitled to receive from the Trust compensation, honorarium for such services rendered, the quantum being decided upon from time to time. The Trustees may also appoint one of the Trustees as Secretary.
